

## **Notice of Examination**

**announces an examination for Corrections Officer**

**Purpose:** to fill current and/or future vacancies in the Shelby Co. Sheriff's Ofc. Correctional Facility  
**Starting Salary:** \$17.18+ per hour; **Maximum Salary:** \$25.52+ per hour, effective 10/3/08  
**Examination Date and Time:** Saturday, February 6, 2010 at 1:00 p.m.; check-in begins 12:30 p.m.  
**Fringe Benefits Include:** Group medical insurance, pension plan, paid vacation, holidays, sick leave, and other types of leave, job security; educational and/or fitness incentives for those who qualify

### **Place and Procedure**

Exam will be held in Chelsea High School lunchroom (10510 Hwy. 11, Chelsea, AL 35043; I-65 Pelham exit 242, E on Co. Rd. 52, N on CR 11, school is on right; or E on Hwy. 280, rt. on Old 280, to Co. Rd. 11, school is 2 miles south on left). Info package available at SCLEPB office, rm. 102 in Butch Ellis Community Svcs. Bldg. behind Courthouse in Columbiana (8-4:30 M-F), or download from Sheriff's Office's website: [www.shelbyso.com](http://www.shelbyso.com). Bring or mail to SCLEPB, P. O. Box 1006, Columbiana, AL 35051 the following items: completed application; résumé; copy of high school diploma **OR** H.S. transcript w/graduation date **OR** G.E.D., even if you attended college; Applicant Statement and Authorization to Release Information form (pg. 18 of application, signed in front of a notary – required for background check); and copies of pertinent credentials/awards/certificates. **Paperwork must be received no later than 4:30 p.m. Thursday, January 21, 2010. We do not mail reminder notices – THIS IS YOUR ONLY NOTIFICATION OF THE WRITTEN EXAM.** Park **behind** the school near the lunchroom. You must show a valid driver license to be admitted. Test administrator checks off list of pre-registered applicants **and locks door at 1 p.m.** Exam takes 2 to 2½ hours. All scores are mailed. Sheriff's Office notifies qualified applicants of fitness test in a few weeks. **This exam is held quarterly, but you may take it only ONCE a year, so please be sure you can pass the fitness test a few weeks later.** Please notify LEPB of name/address/ph. no./job changes.

**Age requirements:** Minimum age to take examination is 18 years; 19 years to be appointed  
**Education:** HS diploma, HS transcript with graduation date, or G.E.D.; submit copy of one with application

**Other:** Applicants must be USA citizens, and must pass the APOSTC fitness test (requirements available in LEPB office or online), background investigation, interviews, personality inventory, polygraph, drug screen, and doctor's physical prior to appointment

**Examination Subjects & Weights:** Ability to follow oral and written instructions; ability to read and comprehend written material; logical reasoning; memory and observation; **Passing score: 70**
